This is a 10 hour a week position with no leave benefits. Starting Salary is \$12,000.00.

The Committee will consider splitting the position and entertain filling it with a Children's Coordinator and a Youth Coordinator if there are no qualified applicants for an individual to fill the position as stated in the paragraph above. This action would need to be presented to the church body for approval prior to any further advertisement.

Applications can be submitted in writing to the Personnel Committee by placing in the mail slot in the GPBC office. If no qualified applicants are received by **November 1, 2020**, the Committee will open the position to the public.
